<u>Meet Format Waiver:</u>	The host club has the right to change the format of the meet. These changes would be made for a more efficient swim meet for the swimmers and the host club. Reasons for these changes include: <ul style="list-style-type: none"> • To conform to facility capacity limits or for facility safety concerns. • To condense the meet into smaller time frame.

<u>Coaches Eligibility:</u>	<ul style="list-style-type: none"> • All coaches “on the deck” must have YMCA coaching certification visible at all times
<u>Swimmer Eligibility:</u>	<ul style="list-style-type: none"> • All swimmers must be listed on a team’s official entry form to be eligible to participate in this swim meet in any events including relays. • All transfer swimmer(s) must swim unattached for 120 days from their last attached competition. Swimmers must use an UN- (New Team Alpha Code) as their team affiliation. All Unattached swimmers must be listed on the team’s official waiver entry form. • There will be 8 & Under Events. • There are no qualifying standards for entry to this meet. • Swimmers are allowed to compete in 3 individual events per day.

	<ul style="list-style-type: none"> Swimmers may compete in one (1) relay per day. Age for this meet is age as of: December 1, 2011
<u>Swimmers Unaccompanied by a Certified Coach:</u>	Any swimmer entered in this meet must be certified by a YMCA member coach as being proficient in performing a racing start or must start each race from within the water. If a swimmer is not accompanied by a YMCA member coach, then it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
<u>Meet Format:</u>	<ul style="list-style-type: none"> This meet will be run in accordance to current USA Swimming Rules. This meet will be run as a timed final meet. This meet will be deck seeded with coaches checking in/scratching all swimmers. When the seeding has been posted, swimmers will report directly to the pool in their assigned events, heats, and lanes.
<u>Meet Schedule:</u>	<ul style="list-style-type: none"> The building will open at 7:30 AM This meet will have one session

<u>Warm-up Procedures:</u>	<ul style="list-style-type: none"> Warm-ups will include general warm-up lanes. Teams will be assigned lanes for warm-ups. When more than two teams share a common lane for warm-ups, all teams must agree to a warm-up procedure. If clubs sharing a lane can't agree on a warm-up procedure, that lane will be a general warm-up lane. All swimmers must enter the pool from the starting end of the pool. The warm-up sessions will be two 30-minute warm-ups divided by teams.
<u>Entry Times:</u>	<ul style="list-style-type: none"> All entry times will be accepted. It is acceptable to use the standard conversion factor to convert times to SCY.
<u>Check-In:</u>	<ul style="list-style-type: none"> All check-in sheets must be turned into the scoring table 30 minutes before the start of each session. Swimmers that are swimming will have a line through their name. Swimmers that are being scratched will have their names circled with a "SCR" next to the circle. Swimmers scratching a single event will have a line through his/her name and the event number circled with "SCR" next to the circle. Failure to follow this procedure may result in the swimmer(s) being scratched from the session.
<u>Starts:</u>	The host club will determine if 'Fly-over'/'Over-the-top' starts will be used after a time line has been produced. This information will be posted in the pre-meet information.
<u>Scoring:</u>	This meet will not be scored
<u>Awards:</u>	<ul style="list-style-type: none"> Ribbons will be awarded for places 1 through 6 in each individual or relay event. Heat winners will receive candy canes.
<u>Entry Fees:</u>	<ul style="list-style-type: none"> Individual Entry Fee: \$4.00 Relay Entry Fee: \$8.00 Make checks payable to: SHY S.T.P.O. Host club has the right to scratch teams/swimmers for lack of payment of entry fees.
<u>Admissions and Programs:</u>	<ul style="list-style-type: none"> Admission will be \$5.00 per session, Children 8 and under are free. One program per family is provided with admission.
<u>Entries:</u>	<p>Team entries may be submitted by E-mail to mgbigini@hotmail.com</p> <ul style="list-style-type: none"> All entries must be submitted using a Hy-Tek program (MM or TM) type file. The meet entry coordinator will respond to e-mails entries within 48 hours. If you do not receive an e-mail response within 48 hours, assume that your email has not been received. It then becomes the e-mailer's responsibility to make sure that the host club's meet entry coordinator receives the e-mail. If you do not receive an e-mail response, you must contact

<u>Results:</u>	<ul style="list-style-type: none"> • Results will be available on the host club website.
<u>Host Club Responsibilities:</u>	<ul style="list-style-type: none"> • The host club will provide a single timer in each lane throughout the meet. • The host club will have stopwatches available for volunteers helping to time. • The host club will e-mail all club entry confirmations back to the participating clubs. • The host club will create a warm-up schedule that will be fair and equal to all teams. This warm-up schedule will be e-mailed to all participating clubs and posted on the website: http://www.shyswimteam.org/ no later than 4 days before the meet. • The host club will create timing assignments that are fair and equitable with as many teams participating as possible. These timing assignments will be e-mailed to all participating clubs and posted on the website: http://www.shyswimteam.org/ no later than 4 days before the meet.
<u>Participating Club Responsibilities:</u>	<ul style="list-style-type: none"> • Participating clubs must help with timing assignments. Timing assignments will be e-mailed to participating clubs and posted on the swim meet website: http://www.shyswimteam.org/ 4 days prior to the meet. • Participating club parents must stay off the pool deck except for timing assignments. • Participating clubs should help with officiating whenever possible. Please notify the referee, Diane Ross, dross@turpinrealtors.com about volunteering as an official.
<u>Concessions:</u>	Concessions will be available throughout the meet.
